The Pervasive Issue In The Modern Digital Age

Introduction

The Australian Motorsport Council ("AMC"), is the united advocacy body representing Australia's motorsport Federations with authority and delegated responsibilities to control, regulate and manage mainstream Australian Motorsport from the International Motorsport Federations – FIAⁱ and FIMⁱⁱ.

Motorcycling Australia is recognised by Sport Australia as the National Sporting Organisation ("**NSO**") for 2-wheel motorsport. Motorsport Australia is recognised by Sport Australia as the NSO for 4-wheel motorsport. Both federations receive funding support from Sport Australia.

Karting Australia, the Australian National Drag Racing Association and Speedway Australia govern the specific divisions of 4-wheel motorsport – Karting, Drag Racing and Speedway under authorisation of the General Assembly of the FIA through formal agreements of delegation of sporting power and general authority to control, regulate, supervise administer and promote their respective division of 4-wheel motorsport from Motorsport Australia.

The five federations are the only motorsport Sporting Organisations recognised by the Federal Governmentⁱⁱⁱ as the "**Authorised Sanctioning Bodies**" of land based motorsport.

About This Position Statement

The Australian Motorsport Council and its constituent members - Motorsport Australia, Motorcycling Australia, Karting Australia, ANDRA, and Speedway Australia, acknowledge the urgent need to address the growing issue of online abuse and hate speech in sports.

As responsible governing bodies in the motorsport community, we firmly believe in fostering an environment that promotes inclusivity, respect, and fair play. Online hate speech not only tarnishes the spirit of sportsmanship but also has severe consequences on the mental well-being of participants, volunteers, officials, and fans alike.

Our Pledge

We, the Australian Motorsport Council and its constituent members, commit to the following principles:

1. Uphold and Promote Best Practices:

Damage to Sports Image

The prevalence of hate speech and online abuse in sports can harm the overall image of the sport and its organisations. Sponsors and partners may reconsider their association with sports that have a reputation for tolerating or failing to address online abuse effectively.

Cyberbullying and Youth Sports
